

For consideration of participation in the **Run MS, Maine Corps Marathon** event to be held on **October 25, 2015**, I, The Releasee, waive and release the National Multiple Sclerosis Society, its chapters, directors, officers, administrators, representatives and executors, past and present employees, volunteers, agents, supervisors, participants, all city and state governments, assigns, all sponsors, their representatives and successors and other persons (collectively, the Releasee's), from any and all claims, liabilities, or causes of action arising out of an injury to me (or my child) and from any and all claims, liabilities, or causes of action arising from my (or my child) participation or attendance in this event.

#### Inherent and Potential Risks

I understand that **Run MS, Marine Corps Marathon** involves strenuous physical activity. I understand that physical activity, by its very nature, carries with it certain inherent risks. I assume all risks associated with participating in **Run MS, Marine Corps Marathon** relating to the risk of strenuous physical activity. I acknowledge that I (or my child) may incur minor injuries, major injuries, and catastrophic injuries including paralysis and death. I assume risks from contact with other participants and volunteers, negligent or wanton acts of other participants and volunteers, failure of other participants, volunteers and non-participants from observing the guidelines of **Run MS, Marine Corps Marathon** or any applicable laws, any defects of conditions of premises, and the effects of weather including high heat, thunderstorms, lightning, precipitation, cold temperatures, high winds, and/or humidity.

I agree to dress myself (or my child) appropriately as to mitigate risk of physical injury to myself (or my child) including, but not limited to: wearing shoes appropriate for strenuous physical activity involved in **Run MS, Marine Corps Marathon**; and dressing in conjunction with the weather.

I agree that the Releasees are not responsible for any personal items or property lost or stolen before, during, or after **Run MS, Marine Corps Marathon**

#### Medical Evaluation

I attest that I (or my child) am medically and physically able to participate in **Run MS, Marine Corps Marathon**. If I experience any doubt as to my (or my child's) ability to successfully and safely participate in and/or complete **Run MS, Marine Corps Marathon**, I take full responsibility for consulting a physician. I attest that, if I (or my child) am pregnant, disabled in any way, or have recently suffered an illness, injury, or impairment, I (or my child) should have or did consult a physician prior to participating in **Run MS, Marine Corps Marathon**.

I consent to emergency medical care and transportation in the event of injury to me (or my child) as medical professionals may deem appropriate. This Release extends to any liability arising out of or in any way connected with the medical treatment and transportation provided in the event of an emergency, including, but not limited to, negligence emergency rescue operations.

#### Voluntary Participation

I am fully aware of the risks connected with participation in **Run MS, Marine Corps Marathon**, whether specifically listed in this Release or not, and I voluntarily elect to participate in **Run MS, Marine Corps Marathon** knowing that this participation involves these risks. I understand that my participation in **Run MS, Marine Corps Marathon** accompanies a minimum fundraising obligation for the benefit of NMSS.

#### Assumption of Risk, Waiver of Liability, Release, and Covenant Not To Sue

In consideration for being permitted to participate in **Run MS, Marine Corps Marathon**, I voluntarily agree for myself, my family, heirs, assigns, executors, and administrators to the following:

1. TO ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, OR PERSONAL INJURY, INCLUDING DEATH that may be sustained by me (or my child), or any loss or damage to property owned by me (or my child), as a result of participating **Run MS, Marine Corps Marathon**.
2. TO RELEASE, WAIVE, HOLD HARMLESS, DISCHARGE, AND COVENANT NOT TO SUE the Releasees from any and all liability, claims, actions, demands, expenses, attorney fees, breach of contract actions, breach of statutory duty or other duty of care, warranty, strict liability actions, and causes of action whatsoever, that I might have or may acquire in the future, arising out of or related to any loss, damage, or injury, including death, that may be sustained by me (or my

child), or to any property belonging to me (or my child), while participating in **Run MS, Marine Corps Marathon** including, but not limited to, any claim that the act or omission complained of was in whole or in part by the negligence or carelessness of the Releasees.

#### Acknowledgment and Compliance with Rules

I agree to observe and obey all rules and safety procedures that accompany **Run MS, Marine Corps Marathon** and to abide by any decision of an event official relative to my (or my child's) ability to safely compete in the event. I agree to exhibit appropriate behavior at all times and to obey all laws. NMSS and event officials may dismiss me (or my child), without refund, should my (or my child's) behavior endanger the safety of or negatively affect an event, person, facility, or property of any kind.

#### Severability

I agree that if any portion of this Release is deemed to be invalid, the remainder of the Release will still be binding and enforceable.

#### Photography Release

I hereby grant full permission to NMSS to use, reuse, reproduce, publish, or republish any photographs, motion pictures, recordings, or any other record of my participation in this event, in any medium now known or hereafter developed, alone or in conjunction with other material, without restriction as to changes or alterations, as well as to use my name, voice, likeness, and/or other indicia of identity, for editorial, educational, promotional, advertising, and commercial purposes, including without limitation in connection with the solicitation of contributions and the furtherance of the corporate objectives of NMSS. Further, I relinquish all rights, title, and interest in any and all photographs, motion pictures, recordings, or other records of **Run MS, Marine Corps Marathon** I may take or capture to NMSS.
